With very serious over-abundance of deer in this area, many home owners now seek seasonal help from bow hunters. (Herds have the reproductive potential to double every two years.) We encourage land owners to invite hunters in early to scout their properties and discuss possible plans. Hunters are not allowed to charge for their service, but contributions for butchering meat going to shelters may be arranged.

The bow-hunting season here in this stressed area runs from September 15<sup>th</sup> until January 31<sup>st</sup>, but the state still forbids Sunday hunting. When you do engage a hunter, always ask to see the hunter's current permit. The Darien Police Department holds documents indicating that these hunters have been trained to state standards. The law requires the land owner to sign a consent form allowing the hunter on the property. Make sure that you hold a copy signed by both parties, and follow up with the hunter from time to time on progress.

You can pick up a current *CT Hunting Guide* from the Town Clerk carrying full details.

Landowners who allow the recreational use of their property without fee are protected from liability by state law. Archers are trained to shoot down from high tree stands, preferably around dawn or dusk. A local authority states that no one in the entire area has ever been struck by a stray arrow. Most hunters prefer wooded areas with secluded sites.

*Deer-vehicle collisions* do present serious hazards with over 500 deer carcasses found and reported yearly on Fairfield County roads. Such dangerous accidents cause over \$2,200 damage per vehicle. There are also reports of human fatalities in the state from accidents triggered by deer. Further, the alarming incidence of the deer-borne, *Lyme disease* is confirmed by the recent local surveys. Some Darien residents report resulting profound disability. Conservation experts say damage to local ecology from heavy *year-round foraging* presents a major concern for our prized woodlands and their potential regeneration.
